

Conditions for workshop tours

Bildgießerei Hermann Noack GmbH + Co. KG (hereinafter: Noack)
Am Spreebord 9, 10589 Berlin

Noack solely conducts workshop tours in accordance with the following conditions:

Noack is a metalworking company. The company premises, workshop and respective facilities are not intended for visitors or viewings. Persons not affiliated with the company are only permitted access to the premises for purposes of the workshop tour and in immediate proximity to the workshop guide. Visitors are prohibited from leaving the tour group. Visitors must remain on the pathways taken by the tour guide. Areas of the workshop and company grounds to which visitors are not explicitly granted access by the tour guide are restricted, and visitors are prohibited from accessing them.

The environment in the workshop and company grounds is not risk-free. Injuries/harm may result from operating or self-activating machinery, equipment, devices, stationary or falling materials, objects, hot objects, leaking substances, structures at head level, water, dirt, dust, steam, electricity, noise, and ground consistency (such as if the ground is uneven, slippery, dirty).

Open flames and smoking are prohibited on the company grounds. Food, beverages, alcohol, and the consumption thereof are also prohibited. Persons under the influence of alcohol, narcotics, or medication are not allowed to participate in the tour. Persons in a delicate medical state and persons with mobility aids or other orthopaedic aids can be prohibited from participating in the tour if Noack believes that the tour will put their health at risk. The company grounds and worksite are not accessible to persons with disabilities.

Works of art, materials, tools, machinery, devices, and other items must not be touched. This especially applies to levers, switches, knobs, buttons, and other control elements.

Instructional signs as well as instructions by Noack and the tour guide must be followed.

Appropriate shoes must be worn at all times.

Visitors are prohibited from taking photos and/or videos (audio and/or visual).

The participants are liable for damages for which they are culpable.

In the event of foreseeable disruptions to operations as well as violations of these requirements by individual participants, the workshop tour can be cancelled as a whole or the respective participants can be excluded from the tour.

Liability limitation

Visitors participate in the workshop tour at their own risk. Visitors have no claim to damages against Noack or the tour guide unless otherwise specified after the fact. The liability limitation does not apply to any damage claims in the event that Noack, its legal representatives or its proxies breach its obligations due to gross negligence or intent, nor to damage claims stemming from harm to body, life or health, nor to the violation of major contractual obligations. In the event of a violation of a major contractual obligation, the sum of the liability is limited to the damages that are typical for the type of contract and foreseeable upon formation of the contract. Major contractual obligations are those upon which proper execution of the contract is contingent, and which the contract partners can regularly expect to be observed.
